CIVIL AIR PATROL UNIFORM REGULATION

CAP Regulation 39-1, dated 3 March 2020, to include Interim Change Letter(s) (ICLs), is supplemented as follows:

- **2.8.4.A, Added.** Any item authorized in this supplement shall not be worn outside the geographic boundaries of the Oklahoma Wing.
- **5.1.1.9.2.1** Added. A navy-blue baseball style hat with the stylized Oklahoma Wing logo may be worn with the USAF Style ABU. For Oklahoma Wing Cadet Encampments and other Wing-wide events, the Wing Commander may limit the wear of this item in writing to specific activity staff positions and/or individual members by name. Hats not procured via the Oklahoma Wing are not authorized. No other colors are authorized.
- **5.3.7.1. Added**. A navy-blue baseball style hat with the stylized Oklahoma Wing logo may be worn with the CAP corporate working uniform.
- **8.2.8.3.1.** Added. The navy blue baseball style hat with the stylized Oklahoma Wing logo shall NOT be worn with the USAF Style Flight Duty Uniform at any time.
- **8.3.8.1. Added.** A navy-blue baseball style hat with the stylized Oklahoma Wing logo may be worn with the CAP corporate flight duty uniform.
- **9.4.1.1 Added**. Academic Shoulder Cord. A single-color orange woven shoulder cord without tip(s) (non-aiguillette) may be worn by cadets who are enrolled in any school that have attained an unweighted grade point average (GPA) of 3.5 or better for the current semester. This cord will not be worn in place of other cords authorized by this regulation. This cord is authorized by the squadron commander after verifying all criteria has been met and is worn for as long as the criteria is met. At the end of each academic term, cadets will present their report cards to the squadron commander for verification of eligibility and continued wear of the cord.
- **9.4.1.2 Added**. Cadets assigned using the "Officer Support" portion of the e-services Duty Assignment feature. A single color black woven cord without tip(s) (non-aiguillette) may be worn by cadets who are assigned to support a wing staff member. Cadets assigned to support any duty position of the wing staff via this mechanism are automatically authorized to wear the black cord while currently assigned in e-services to this role. Once the support assignment has ended, the wear of this shoulder cord is no longer authorized.
