CIVIL AIR PATROL UNIFORM MANUAL

CAPM 39-1, dated 23 March 2005, is supplemented as follows:

Table 1-1. Wearing the Uniform NOTES:

Added: 3. The battle dress uniform (BDU) is a utility work uniform. It is appropriate to wear when performing manual labor, participating on a ground team, or when authorized at a unit meeting by the unit commander. It SHALL NOT be worn in school, at non-CAP meetings, or when interfacing with the public. Members should make only essential stops enroute to and from the duty performance site. If the stop is essential, members must meet the proper standards of neatness, cleanliness, and military/CAP image. All "web gear" will be removed before making the essential stop.

4. Unit commanders are authorized to suspend the wear of the uniform at the unit level if they feel it places their members at risk.



- 1. Baseball caps as shown in the figure 1 and figure 2 are authorized for wear with BDU's or flight suits. No other baseball caps are authorized for wear with Air Force style or CAP distinctive uniforms. These caps may be purchased through Group 1. Contact the Group 1 Commander for purchasing details.
- **2.** Ground teams in utility uniforms are authorized to wear "orange" baseball cap for safety and visibility. Optional unit designation as described below is authorized.
- **3.** Local units may obtain approval for baseball caps and other items for use as fundraisers, gifts for dignitaries, etc. by submitting a high resolution color bitmap image of the insignia or sample item with a complete description through the chain of command to the Illinois Wing Director of Administration (ILWG/DA). If approved by the Wing Commander a letter of authorization will be returned to the local unit.







DESCRIPTION

Black (or orange) baseball cap
Embroidered Illinois Wing shoulder patch on front
Unit name embroidered above wing patch
Unit number (GLRILxxx) embroidered below wing patch
Senior member Major thru Major General are authorized to
wear clouds and lightning (Figure 3) on cap visor.
No other name or writing is authorized.

4. No grade insignia, pilot/observer wings, ground team insignia or other pins may be worn.
