## CIVIL AIR PATROL UNIFORM MANUAL

CAPM 39-1, 1 July 1997, is supplemented as follows:

## **Table 5-3, item 6.**

1. Requirements for award of Communicator's Patch: Technician Level in Communications.

## Table 5-3, item 9.

- 1. Requirements for award of Emergency Service Patch:
  - a. Hold a valid Emergency Services Qualification Card (CAP 101) issued by proper authority and accompanied by a current CAP membership card.
  - b. Participate in a minimum of two (2) ES missions after qualification in an emergency services specialty. These mission (SAR, CD, DR) must be either actual (under an Air Force or State mission number) or an Air Force authorized training/evaluation SAR or DR mission. Participation in each mission must be certified by the CAP Mission Coordinator or Air Operation Officer.
- 2. Procedures for award of Emergency Services Patch:
  - a. The applicant must submit a completed CAP Form 2a, Request for and Approval of Personnel Actions, to the unit commander requesting the award of the Emergency Services Patch.
  - b. The unit commander will verify that the applicant has fulfilled the requirements before

- approving the award of the Emergency Services Patch.
- c. The unit will forward a copy of each award of Emergency Services Patch (CAPF 2a) to the Wing Director of Emergency Services.
- 3. Authority to wear an Emergency Services Patch:
  - a. A CAP member awarded the Emergency Services Patch by proper authority may continue to wear the patch only as long as CAP membership is maintained and the member holds a valid Emergency Services Qualification Card (CAPF 101).
- 7-3a. (1) Added. A fourragere (shoulder cord) will be worn by members of the West Virginia Wing Cadet Drill Team. The fourragere will be blue and gold. The fourragere will be presented to the active members of the cadet competition team following the Middle East Region Cadet Competition, at such time and place as the Wing Commander may direct. The fourragere may be worn by the team members performing the duty for which the use of the fourragere was authorized until 1 October of the following year. The fourragere must be returned to the Wing Director of Cadet Program at that time or whenever the cadet to whom it is issued ceases to be an active member of the team. The unit commander of each team member is responsible to see that the fourragere is returned to wing headquarters. The fourragere is to be worn on the left shoulder of the blue uniform only. The individual to whom the fourragere is issued is responsible for keeping it clean and in good repair, and for replacing it if lost or destroyed.

**7-3a. (2)** Added. A fourragere (shoulder cord) will be worn by members of the West Virginia Wing Cadet Color Guard Team. The fourragere will be blue and silver. The fourragere will be presented to the active members of the color guard team following the Middle East Region Cadet Competition, at such time and place as the Wing Commander may direct. The fourragere may be worn by the team members performing the duty for which the use of the fourragere was authorized until 1 October of the following year. The fourragere must be returned to the Wing Director of Cadet Program at that time or whenever the cadet to whom it is issued ceases to be an active member of the team. The unit commander of each team member is responsible to see that the fourragere is returned to wing headquarters. The fourragere is to be worn on the left shoulder of the

blue uniform only. The individual to whom the fourragere is issued is responsible for keeping it clean and in good repair, and for replacing it if lost or destroyed.

7-5 All members of the West Virginia Wing flying in CAP aircraft during an operational mission (numbered missions) will wear the following CAP uniforms CAP dark blue BDU, AF BDUs, CAP dark blue flight suits, or AF style flight suits. The CAP golf shirt and gray dress pants are not authorized.

The only exception to the above paragraph is when an outside agency, such as the DEA, requests the aircrew to wear civilian clothing. The golf shirt is still prohibited.
